**OFFICE MEMORANDUM**

**Sub: Exercise of option for availing the benefits of family pension upon in-service death in respect of State Government employees covered under National Pension System (NPS)**

State Government in Finance Department have prescribed procedural guidelines pertaining to exercise of option for availing the benefits of family pension upon in-service death in respect of State Government employees covered under National Pension System (NPS) vide FD OM No. 12587/F, dated 19.05.2022.

2. As per Paragraph-2(A)(I)(b) of the aforesaid O.M., existing State Government employees, covered under NPS, were initially given a period of one year from **19.05.2022**, i.e. from the date of issue of the OM, to exercise their option in Form-I. Subsequently, the timeline was extended up to 19.05.2024, vide FD OM No. 21877/F, dated 03.08.2023, read with FD Corrigendum No. 23885/F, dated 23.08.2023.

3. It has, however, been brought to the notice of the Government through representations from various State Government Offices that a number of employees covered under NPS could not exercise their option in Form-I within the revised timeline, i.e. by **19.05.2024**.

4. Therefore, after careful consideration, the Government have been pleased to allow the State Government employees covered under National Pension System, who were already in service at the time of issue of FDOM No. 12587/F, dated 19.05.2022, to exercise their option by **31.01.2026**.
