
Madam/ Sir,

Further you are also requested to furnish the GPF account Number / PRAN No. of the Nursing Personnel (Nursing Officer, Senior Nursing Officer, Assistant Nursing Superintendent, Deputy Nursing Superintendent and Nursing Superintendent of Odisha Nursing Service Cadre) so as to enable this Directorate to access the submission of Property Statement by the employees which is required for DPC for their promotion and also furnish the present place of posting of Nursing Officer as well as the home district of Nursing Officer against each of them name in the Provisional Gradation List.


